MACMC ride events traverse public roads and highways. MACMC is not responsible for the conditions of these roads and highways, nor for the behavior of / or hazards caused by other individuals using public roads and highways. MACMC is also not responsible for any changes in event routes that may occur since they were first planned. Each participant is solely responsible for the safe and successful operation of his or her vehicle during these events.

RELEASE AND WAIVER OF LIABILITY

ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration for being permitted to participate in any way in MACMC events during the calendar year _____ the undersigned, for himself or herself, personal representatives, next of kin and heirs :

- 1) Hereby releases, waives and discharges from all liability, and covenants not to sue MACMC, its members, officers or directors (hereinafter referred to as " releasees ") for any and all loss or damage, any claim or demands therefore on account of injury to the person or property, or resulting death of the undersigned arising out of any MACMC event whether caused by negligence of the releasees or otherwise.
- 2) Hereby agrees to indemnify and hold harmless the releasees and each of them from any loss, liability, damage, fees or costs which they may incur arising out of or related in any manner to my attendance at or participation in a MACMC event whether caused by the negligence of any releasee or otherwise.
- 3) Hereby assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to a MACMC event whether caused by the negligence of any releasee or otherwise.
- 4) Hereby acknowledges that the activities of these events can be dangerous and involve the risk of serious injury and / or death and / or property damage. The undersigned also expressly acknowledges that any injuries received may be compounded or increased by the negligent rescue operations or procedures of the releasees.
- 5) Hereby agrees that this Release And Waiver Of Liability, Assumption Of Risk And Indemnity Agreement extends to all acts of negligence by the releasees, including negligent rescue operations and is intended to be as broad and inclusive as is permitted by the laws of the State in which the events are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
